And we used this recognition of their selfless, brave and heroic service to repeat calls for leaders to put an end to the suffering and deliver lasting peace and justice for all.

We must continue to use our voices, our education and our many other advantages to help communities who need it most.

Because standing up for peace, justice and humanity is the responsibility of us all.

2024 SYDNEY PEACE PRIZE

The 2024 Sydney Peace Prize was awarded to the International Red Cross and Red Crescent Movement. Recognising a humanitarian network of more than 16 million volunteers and staff, dedicated to saving lives and preventing the suffering of people affected by armed conflict and committed to upholding International Humanitarian Law.

In a year that marks the 75th anniversary of the adoption of the Geneva Conventions—and at a time when International Humanitarian Law faces unprecedented challenges—their work remains as vital and relevant as ever.

Throughout 2024, we worked closely with the highly professional and collegiate team at the Australian Red Cross. We are enormously grateful for their expert advice and insights and their willingness to manage the logistics for the delegation from the International Federation of the Red Cross (IFRC), who visited us in November.

The \$50,000 Sydney Peace Prize award funds were directed towards funding Australian Red Cross medical delegates volunteering at the IFRC field hospital in Gaza.

This award is a testament to the dedication of our 191 National Red Cross and Red Crescent Societies' staff and volunteers. Many are working in some of the most challenging and dangerous environments in the world. Their dedication reflects the fundamental principles and values that define our Movement.

Sydney Peace Prize Annoucement

Sydney Town Hall Peace Prize Lecture and Ceremony


The landmark event commenced with a stunning Acknowledgement of Country and a performance from three talented performers from the NSW Arts Unit Aboriginal Dance Group.

Cabramatta High Peace Day

This was again a highlight of Peace Week. Over 2,500 students from across western Sydney came together in a celebration of diversity and peace. The Cabramatta High event included colourful student performances from around the world and a release of 100 doves into the blue sky above hundreds of students and guests.

Alexander Matheou from the International Federation of the Red Cross, Australian Red Cross delegate Christine Evans and the Australian Red Cross team were greeted by hundreds of enthusiastic students, many in traditional dress. Dignitaries, including local Federal MP Dai Le, NSW Department of Education officials and representatives from the Sydney Peace Foundation, were among those who accompanied Cabramatta High Principal Lachlan Erskine and our Peace Prize Laureate on a school tour.

SYDNEY PEACE FOUNDATION PUBLIC EVENT PROGRAM

Throughout 2024, the Sydney Peace Foundation hosted and produced a number of engaging and thoughtful conversations and public events. These events supported the Sydney Peace Foundation's goal of aligning with both the teaching and learning objectives of the University of Sydney, while also strengthening the Foundation's strategic engagement initiatives. We thank the Highgate Foundation for supporting this public event program.

March 2024: Daily Life in Palestine with Nathan Thrall

Drawing on a decade spent as the director of the International Crisis Group's Arab-Israeli Project, Nathan Thrall was in Sydney to discuss his new book, A Day in the Life of Abed extraordinary Salama, an history that illuminates the reality of daily life in Palestine. He was joined by Rawan Arraf, Executive Director at the Australian Centre for International Justice (ACIJ) and Dr Ihab Shalbak, from the University of Sydney's Faculty of Arts and Social Sciences.

April 2024: Anzac Day Reflection

At an event organised by Marrickville Peace Group on Anzac Day, Sydney Peace Foundation Director Melanie Morrison's address was a plea for more humanity and decency in a world wracked by war and conflict.

June 2024: The Trial of Jimmy Lai, Media Freedom and Democracy in Hong Kong

This was a far-reaching discussion about Jimmy Lai, renowned prodemocracy campaigner, media entrepreneur, writer and founder of Apple Daily, on trial in Hong Kong and facing the possibility of a lifetime in prison.

His son, Sebastien Lai, was visiting Australia, along with lead counsel and liberties expert. Caoilfhionn civil Gallagher KC. Professor Ben Saul, Challis Chair of International Law at the University of Sydney and the United Nations Special Rapporteur, and award-winning barrister Jennifer Robinson ioined also the attended discussion.

July 2024: Rotary Sydney, a Boardroom Dialogue - The Sydney Peace Prize 2024

At this boardroom lunch Sydney Peace Foundation co-chair, Felix Eldridge, and Amnesty International's Mohamed Duar walked us through the unique place the Sydney Peace Foundation and the Sydney Peace Prize have on the world stage. They discussed the process and reasoning for the choice 2024 recipient of the the International Red Cross and Red Crescent Movement.



August 2024: Human Rights and Democracy in Indonesia

Human Rights Watch's Indonesia Researcher Andreas Harsono and Sydney Peace Foundation's Melanie Morrison discussed the state of human rights in Indonesia under the new president-elect Prabowo Subianto. In this discussion, Andreas delved into the state of human rights in Indonesia and shared his concerns for the future.

This event was hosted by the University of Sydney's Master of Social Justice program and the Sydney Peace Foundation in partnership with Human Rights Watch.

September 2024: NoWar Conference

As part of this global conference to coincide with International Peace Day, Sydney Peace Foundation's Melanie Morrison hosted a panel entitled 'Working Towards an Independent and Peaceful Australia'. The panel included Pastor Ray Minniecon, Kabi Kabi and Gureng Gureng Elder; Lilli Barto, campaigner for Wage Peace; and Dr Albert Palazzo, strategic military policy thinker and formerly the long-serving Director of War Studies for the Australian Army.

The conference was organised by World Beyond War (USA), with the Australian segment of the event hosted by Raising Peace.

September 2024: Women's Club Lecture

In September, Dr Jane Fulton, Co-Director of The Sydney Peace Foundation, was joined by Kate Miranda from the Australian Red Cross to discuss the role of the Red Cross in disaster and conflict zones. We are grateful to the Women's Club for hosting this event.

October 2024: Weapons, Climate Justice and Ethical Investing

The Sydney Peace Foundation, with the support of the Australia Institute, the School of Social and Political Sciences and the Law School, hosted a discussion that tackled the moral and ethical obligations integral to research and investing priorities.

The high-profile panel comprised Professor David Kinley, who holds the Chair in Human Rights Law at the University of Sydney Law School, Dr Claire Parfitt, a Lecturer Political Economy the in at Sydney, University of and Richard Denniss, the Executive Director of the Australia Institute. The extended Q&A discussion was moderated by Sydney Foundation Director Melanie Morrison. Dr Ihab Shalbak from the School of Social and Political Sciences wrapped up the lively discussion.



OTHER DONOR AND PARTNER EVENTS

The Sydney Peace Foundation is lucky to have an outstanding network of donors and partners who host events throughout the year, in addition to those public events listed above.

In August, long term Sydney Peace Foundation supporter Sam Meers hosted an intimate gathering for the Sydney Peace Foundation. We heard from Leanne Smith, international human rights lawyer, former diplomat, UN civil servant and current Chief Executive of the Australian Human Rights Commission, Kate Miranda from the Australian Red Cross and members of the Sydney Peace Foundation about the 2024 Sydney Peace Prize recipient.

In October, the Sydney Peace Foundation supported council member and Director of the Master of Social Justice program at the University of Sydney, Susan Banki, on discussions on human rights, politics and conflict in Myanmar.

As part of our NSW Teachers Federation partnership, we are involved in a peace education program for Federation members. In **December**, the University of Sydney's Dr Jake Lynch and the Sydney Peace Foundation's Melanie Morrison and Patricia Garcia presented a module to Federation members focused on positive peace, moving from theory to practice. This is part of a broader partnership that will be rolled out in **2025**.





PEACE AND SOCIAL JUSTICE SCHOLARSHIP

Our mother's life was one of moral courage and higher purpose. Establishing this scholarship at the University of Sydney, a place that's meaningful to our family, allows her legacy to impact the next generation.

In 2024 the University of Sydney launched the Peace and Social Justice Scholarship, established by Melanie Morrison and her siblings to honour their mother, Marty Morrison. Marty, a lifelong educator and activist, was dedicated to peace, human rights, and social justice - values she passed on to her family and inspired in countless others around the world. The scholarship supports Master of Social Justice students at the University of Sydney.



The Sydney Peace Foundation has also partnered with Rotary International to promote the Rotary Peace Fellowship. These Fellowships are designed for leaders with work experience in peace and development. Annually, Rotary awards up to 130 fully funded fellowships for dedicated leaders from around the world to study at leading global peace centres.

RESEARCH PARTNERSHIP

the Sydney In 2024. Peace Foundation, the Centre for Armed Violence Reduction (CAVR), (headed adiunct academics by at the University of Sydney Philip Alpers and Alistair Gee), and the Faculty of Arts and Social Sciences (FASS) at the University of Sydney signed a partnership to support information stakeholder and management systems to reduce deadly violence, especially in countries at risk of armed conflict.

These systems seek to help people on three aspects of peace with justice: preventing violence, reporting violence, and achieving justice through ending impunity.

Under the agreement, SPF and CAVR opportunity offer the to host University of Sydney student interns, placements and volunteers to work aspects of peace on these three with justice. CAVR will also provide research and support to SPF and FASS academics to use in relevant research projects and applications.






SOCIAL MEDIA

The Foundation successfully broadened its impact in 2024, as reflected in an upward trend in audience reach and engagement across social media platforms.

On Facebook, our content reached 39K people, a 24.6% increase from 2023, meaning more people are seeing our posts, stories, and ads. However, content interactions and link clicks declined by 17-19%, indicating that while visibility improved, engagement did not follow the same trajectory. On a positive note, we gained 254 new followers, a 67.1% increase from the previous year, bringing our total to 3,822. This growth suggests a rising interest in our content.



Our Instagram performance showed an inverse trend. While reach dropped by 66%, content interactions doubled, reflecting a 100% increase. We also gained 202 new followers. The trends suggest that although fewer people are seeing our content, those who do are highly engaged. This indicates strong audience interest, despite the platform's overall visibility decline

On LinkedIn, we experienced steady growth, gaining 334 new followers, a 30% increase, reinforcing our expanding influence on the platform. Meanwhile, we were unable to access analytics for X (formerly Twitter), but given widespread disengagement across the platform, we suspect an overall drop in both followers and engagement.

THE PEACE PODCAST

In 2024 the Sydney Peace Foundation launched an exciting Peace Podcast series highlighting the work researchers and practitioners who work for peace with justice. The initial three episodes of the Peace Podcast were produced and hosted by Emily Whitehead, a University of Sydney student completing her student internship program.

HUMAN RESOURCES

Given resourcing and funding constraints, staff costs were kept at a minimum in 2024. Dr Jane Fulton was employed as the Foundation's much valued Co-Director until May 2024. After this time, Jane moved on to the Sydney Peace Foundation Executive Council as a volunteer in the role of the Director of Philanthropy and Melanie Morrison moved to the sole Director role, employed three days per week.

Moving forward, sufficient staff resourcing throughout the year and particularly around major events will be a priority. Proper staff resourcing will also enable the Sydney Peace Foundation to undertake new development activities to strengthen its impact.

FINANCIAL REPORT SUMMARY

The Sydney Peace Foundation ended 2024 in a strong position with a closing balance of \$229,088.

This comfortable surplus aligns with the years 2011 and 2018, when Professors Noam Chomsky and Joseph Stiglitz were respectively awarded the Sydney Peace Prize.

Our healthy financial results are largely due to the tremendous number of volunteer hours put in by Director of Philanthropy, Dr Jane Fulton, and Foundation Director, Melanie Morrison. Melanie is employed three days a week, which has helped us to keep operating costs to a minimum. Our fundraising efforts and expanded partnerships contributed to our encouraging bottom line.

This year, we raised **over \$380,000** from fundraising and partnerships. From our Gala Dinner we made **over \$186,000**, of which **almost \$54,000** came from the silent auction and raffle.

A key focus in the years ahead is to ensure a properly resourced and sustainable Foundation. To achieve this, we need to expand our reach as well as continue conversations with our major donors and secure more long-term funding through partnerships and engagement.

The Sydney Peace Foundation is committed to the University's governance principals as follows:

PRINCIPLE 1: LAY SOLID FOUNDATIONS FOR MANAGEMENT AND OVERSIGHT

Nature of the entity

The Sydney Peace Foundation is a part of the University of Sydney ABN 15211513464 and not separately incorporated under a state or Commonwealth Act. The Foundation is required to gain prior approval for its fundraising activities from the appropriate University delegate. The Foundation's activities are not-forprofit and covered by the DGR status of the University of Sydney.

The University is exempted from the requirement to hold an Authority to Fundraise and obligations upon holders of such an authority but is still required to

comply with the balance of provisions of the Charitable Fundraising Act.

Roles of Board / Council and Management

The Foundation operates under the authority of the Senate of the University of Sydney, as approved on 3 May 1999, and has no powers of delegation.

The Foundation conducts its affairs pursuant to the Foundation Rules and the relevant policies of the University. The Sydney Peace Foundation had its annual fundraising plan approved and exceeded its objective.

PRINCIPLE 3: STRUCTURE OF THE COUNCIL

Council members have been provided with the University of Sydney Foundation Governance Guide, Foundation Rules, Code of Conduct, Work Health & Safety policy, and the External Interests policy. All policies are available on the University's Policy Register, as are other relevant University policies regarding harassment, grievance procedures and the Delegations of Authority.

PRINCIPLE 4 - SAFEGUARD INTEGRITY IN FINANCIAL REPORTING

The annual accounts of the Foundation are prepared by the financial staff of the University, signed off by Dave Oosthuizen and included in this Annual Report to the Senate. The Foundation is part of the University and therefore does not have its own audit subcommittee. While the Annual Financial Report of the University is audited by the Audit Office of NSW, the Annual Report of the Foundation has not itself been audited. The Foundation undertook the following fundraising appeals during 2024: Annual Tax Appeal in June 2024, and phone calls with major donors, partners and sponsors.

PRINCIPLE 5 - MAKE TIMELY AND BALANCED DISCLOSURE

The Foundation complied with the reporting and disclosure requirements of the Senate. These include an annual budget and this Annual Report. Members and Council have been made aware of the processes for disclosure pursuant to the Code of Conduct, External Interests policy, which include protected disclosure to the ICAC, to the Ombudsman or the Auditor General.

PRINCIPLE 6 - RESPECT THE RIGHTS OF SHAREHOLDERS MEMBERS STAFF, VOLUNTEERS, CLIENTS AND OTHER STAKEHOLDERS

The Foundation Council consist of members of the community, industry bodies and the University whose input is invited via the Annual General Meeting and Council meetings.

PRINCIPLE 7 - RECOGNISE AND MANAGE RISK

The Foundation has managed these risks during the year by offering an opportunity to discuss OH&S and conflict of Interest at every Council meeting.

PRINCIPLE 8 - REMUNERATE FAIRLY AND RESPONSIBLY

No member of Council is entitled to receive any remuneration for acting in that capacity except reasonable remuneration on a basis which has first been approved in writing by the University Officer (Foundations). Members of the Foundation Council may be reimbursed for reasonable expenses after written approval of the University Officer (Foundations). Any such instances are recorded in the minutes of the Council.
